I have been serving as a Special Referee in Clarendon County since the mid 1990's. Our Master in Equity at that time was William C. Coffey and his firm had closed most of the loans in Clarendon County. Therefore he would often have a conflict of interest in hearing foreclosure cases so many cases were referred to me. When he retired as Master, his son, Joseph K. Coffey, took over as Master and I continued to have a lot of referrals since the conflicts of interest remained. I began to hear cases in neighboring counties (Sumter and Williamsburg mostly). Now that Berkeley County has no Master in Equity, I have been doing many cases in Berkeley County as well.

In addition to serving as Special Referee in many cases, I have represented clients in cases in the Master in Equity (or Special Referee) courts across the state. In the past 5 years, I estimate that I had 3-5 cases per month on average and since starting to handle cases in Berkeley County, that has increased to more than 20 cases in Berkeley County alone.

- (a) Anthony Sharpe v. Case Produce Company, 336 S.C. 154, 519 S.E.2d 102 (1999) I served as trial and appellant counsel for Case Produce Company. The Commission basically held that an employee who claimed to have been injured at work was essentially presumed to have been injured at work. The Supreme Court agreed with our position that the burden of proof in proving any injury occurred at work must rest with the claimant and not with the employer.
- (b) <u>State vs. Marcus Joseph</u> This was my first General Sessions death penalty case and I was assistant counsel with Ray E. Chandler. I believe it was significant because it involved many issues of contract murder, interstate jurisdiction and extradition, the death penalty and negotiations both with the prosecution and with our client. I learned a great deal in this case so it has personal significance to me.
- (c) <u>Jackie Eadon Chalfant v. Carolinas Dermatology Group PA</u>, et al. No. 5977 (S.C. Ct. App. Apr. 12, 2023) I assisted with the trial of this case and assisted in arguing the appeal before the Court of Appeals. We prevailed on some issues of the appeal and did not prevail on others. This was significant because it is probably the largest value case I have actually tried and although we did not initially prevail at the trial court level, we prevailed at the appellant level and upon remand were able to settle the case.
- (d) Estate of Bates Coy McCutchen v. Federal Express, et al I served as the Personal Representative of the Estate and thus as the Plaintiff in this matter. It was quite a tragedy and the case was resolved through mediation but dealing with the family and the issues involved moved me quite a bit as a man and as an attorney. Bates Coy McCutchen's father and grandparents have been long time clients and friends of mine so seeing them hurting was a painful process. I was very pleased and impressed with the conduct of the attorneys involved in the case, on both sides, as it was all done in a highly professional manner with great respect for the feelings of the family.

Although suit was not filed, the resolution of the issues was a model in my mind for how things would be handled in a more perfect world.

- (e) Shirley Pirro Scafati v. Aldo Scafati I represented Aldo Scafati in this divorce action. Mr. Scafati was about 100 years old and had a child bride of 86. They had only been married a few years. She sought a divorce on physical cruelty because he hit her with a frying pan once and stabbed her in the head with a butter knife once. Mr. Scafati could not drive so when they had an argument, his method of "storming out" was to have the police come arrest him. He was also a millionaire. I negotiated a settlement and we resolved it favorably but just meeting and getting to know Mr. Scafati was such a treat that it will always be a significant case to me. His zest for life and his approach to things helped me see the practice of law clearly. It also reminded me that people need our help and that helping can be a mutually enjoyable experience.

Robinson, and W. T. Geddings, Jr. d/b/a Geddings <a href="Law Firm">Law Firm</a>, 2000-CP-14-34. My associate, Scott L. Robinson, handled a real estate closing for Mr. Bhupen Patel and Mr. V. Patel. In the title search, Mr. Robinson encountered a mortgage and the Patels gave him a printout of the balance they claimed was due on the note secured by the mortgage. Mr. Robinson based his calculations on that amortization and completed the closing. Later, Bhupen Patel claimed that the printout (which he provided to Scott Robinson) was incorrect and alleged that Scott Robinson should not have taken his word for it and should have demanded the original documents. Neither of the Patels had paid Scott Robinson to handle any payoff of loans nor any other service related to the loan/mortgage. The case was resolved and I had no liability nor was I required to make any payments.
- (b) I have filed suit in Magistrate's Court on behalf of Geddings Law Firm, PA to collect unpaid fees.
- (c) I have been involved in litigation in Magistrate's Court and Common Pleas Court involving lenders and various entities but none are relevant to this application.
- (d) I am a party in <u>Jane U. Geddings & William T. Geddings Jr. vs. Blaster Boys LLC.</u> 2019-CP-14-00486 This is a property dispute with a neighbor and it is still pending.
- (e) I am a party in New Residential Mortgage LLC v. Todd S. Crawford, et al, 2020-CP-14-00023

   this is a dispute over a lien on property owned by Crawford and later conveyed to my wife and I. This is still pending. My wife nor I are involved in the lien foreclosure portion of the suit but are not liable for any note or debt on the property.

Civility between attorneys and litigants seems to be lacking and I would hope to restore some of that by treating everyone with courtesy and respect. Too many media presentations (television shows, movies and news programs) seem to promote unrealistic ideas about the legal system and one of my goals would be emphasis respect, fairness and integrity. It is a stressful situation but I believe that I do very well in stressful situations so I believe I can help litigants understand the legal issues, as compared to emotional responses, and facilitate cooperation between the attorneys.

In my time as Special Referee, I have encountered many litigants representing themselves so it is very important to take more time with them than with attorneys and to keep in mind that they do not understand the process. Since I cannot render legal advice, I have to remind them that they should consult an attorney who can advise them and I try to take a bit of time to explain legal terms or what is happening. Since many of the cases are foreclosure cases, most people just want someone to hear that they are trying to make the payments and even though their efforts do not effect the outcome of the case, they seem to appreciate when someone says that they understand and sympathize.

I realize that I do not live in Berkeley County presently but I did not find any requirement that the Master in Equity live in the County. Regardless of that, if selected for the position my wife and I would be moving to Berkeley County as quickly as we can find a home. As I mentioned above, my daughter and son-in-law are expecting our first grandchild in late September and live in Summerville. Berkeley County will be closer to them and I know my wife especially will be excited to see her grandson more often. We have friends and family in that area so we are looking forward to moving to Berkeley County.
