The work of the Center for Performance and Impact focuses on strategies 5 and 6 in *Each Child, Our Future*: “Assessments and accountability need to create a system of measurement and feedback that supports a continuous improvement culture driven by data.” To accomplish the center’s purpose and support strategies 5 and 6, staff ensure credible data sources and resources, build capacity for data use and understanding and provide resources for using evidence. There are three offices in the Center for Performance and Impact. They include the Office of Accountability (including Community School Sponsor Evaluation), Office of Assessment and Office of Research, Evaluation and Advanced Analytics. The Office of Accountability works closely with the Report Card Project team to develop and implement data and technology aspects of Ohio School Report Cards.

Center for Student Supports

A successful student learning experience is enabled by equitable inclusion of all students and meeting the needs of the whole child, including students' physical, mental, behavioral and social-emotional health needs. The Center for Student Supports focuses on supporting the whole child with specific attention placed on strategies 7 and 8 of Ohio's Strategic Plan for Education, *Each Child, Our Future*, through the dedicated efforts of three program offices. The center's offices include the Office of Early Learning and School Readiness, Office for Exceptional Children and Office of Integrated Student Supports.

The Office of Early Learning and School Readiness supports the areas of preschool and school-age child care licensing in schools, Early Childhood Education grants, Head Start collaboration, early childhood curriculum and assessment, including Ohio's Early Learning Assessment and Kindergarten Readiness Assessment-Revised and Preschool Special Education.

The Office for Exceptional Children supports special education and gifted education. Specific topic areas include special education dispute resolution (mediation and facilitation of individualized education program meetings, complaints and due process), special education supports and monitoring, related services, IDEA fiscal requirements, low-incidence disabilities, special education profiles, data and reporting, gifted education and written education plans.

The Office of Integrated Student Supports focuses on meeting the needs of the whole child, including vulnerable student populations (English learners, homeless students, students in foster care, justice-involved youth), family and community engagement, child nutrition, school-based health care, school attendance, school culture and climate, school safety, social and emotional learning and mental/behavioral health.

Unit of Field Relations

The Ohio Department of Education's Unit of Field Relations serves as a liaison between the Department and the field. The purpose of the unit is to connect the dots among all stakeholders to ensure that, in Ohio, each child is challenged, prepared and empowered. The vision for this diverse set of offices is to provide the necessary support and resources to all stakeholders. The unit strives to provide the field with a "magical" customer service experience rooted in respectful communication while maintaining strong relationships.

The Office of Field Services and Pupil Transportation supports schools and school districts in the areas of School Finance and Transportation. Area coordinators are available to assist schools and districts in the following areas: district of residence (DRC), Education Management Information System (EMIS), excess cost, catastrophic costs (Cat Costs), tuition cost reimbursement, open enrollment, auxiliary services, transportation eligibility and costs, and administrative costs. Transportation professionals assist schools and districts with all phases of pupil transportation, including legal compliance, required reports and funding.

The Office of Nonpublic Educational Options is responsible for implementation of school voucher programs: Autism Scholarship; Cleveland Scholarship; EdChoice Scholarship; EdChoice Expansion Scholarship; and Jon Peterson Special Needs Scholarship. The office works with private schools to obtain and maintain their charters to operate, disseminates information about private schools that are religious but do not request a charter to operate and provides support to families who choose to home school their children.

The Office of Ohio School Sponsorship performs sponsorship activities for the community schools sponsored by the Ohio Department of Education. This includes monitoring, oversight, technical assistance and overall school improvement activities.
